- To open an old age home for old men and women where the senior citizens shall feel at home and live with like-minded associates without paying such exorbitant fee as may result in the making of profit in the hands of the organizers of the old age home
- To open rehabilitation centers, charitable dispensaries or small hospitals having obtained proper licenses from competent authorities to arrange accommodation, care and treatment of sick, helpless or indigent persons and while doing so charity will precede all other considerations.
- To support and donate in cash or in kind to the government, semi-government or non-government organizations that rehabilitate, arrange care and treatment as a regular activity of sick, helpless or indigent persons.
- To open rehabilitation centers for mentally retarded children or victims of cerebral palsy, physically handicapped children with arrangements of modem and scientific techniques for their education and training with the sole purpose of charity.

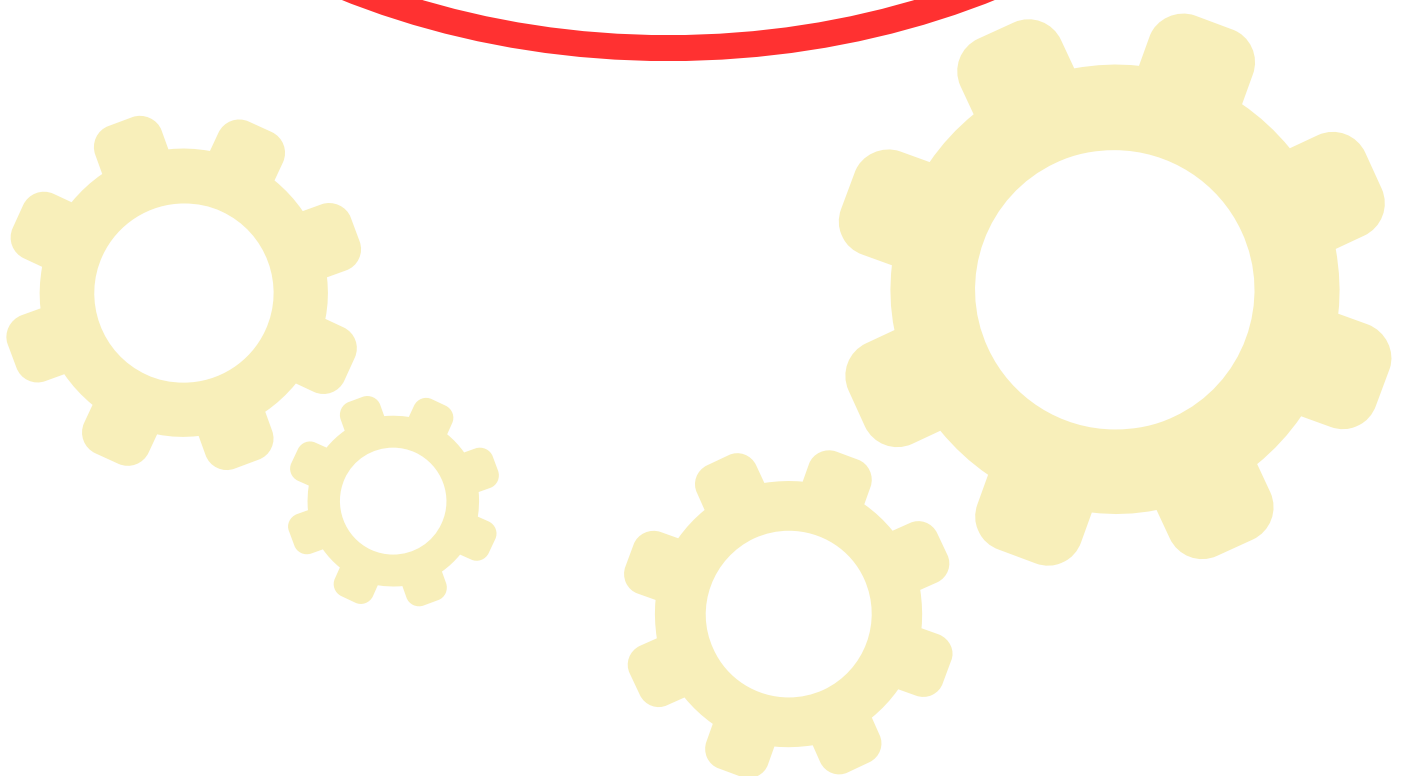

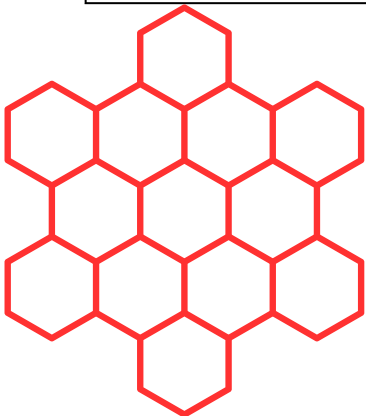
